Dear Ms. Nelson:

This letter is a follow-up to the Department’s findings regarding the interim inspection conducted at your home on 07/26/2023. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Family and Group Child Care Homes.

When I arrived for the inspection Ms. Nelson was providing care to five children; three unrelated, one related under six years of age, and one related over six years of age. Children transitioned from outdoor play to resting. Ms. Nelson has a sufficient amount of developmentally appropriate equipment for the children to choose from. Technical assistance was provided to Ms. Nelson for the children’s wading pool. I discussed with Ms. Nelson the requirement of emptying the wading pool each time children are done with water play.

The violations that were found are:

On 7/26/2023, you gave us an acceptable written corrective action plan.


