## IV. Description of Findings and Conclusions

The terms of the license have been modified on 08/17/2022, 08/03/2022, 02/11/2019 and 02/11/2018.

### A. Description of Facility

The facility is a single-story home without a basement (only a crawl space). The home is located outside the city limits of Graying in a rural setting near Lake Margrethe. The home has a detached garage.

**Rooms and levels approved for child care use:** The kitchen, dining room, living room, master bedroom and two additional bedrooms are approved for child care use. The bathroom, located by the two additional bedrooms, will be used by the child care children.

**Areas not approved:** The laundry room and the bathroom located in the master bedroom are not approved for child care use.

**Ages of children served:** Ms. Nicholas will provide care for children ages birth thru 17 years of age.

**Equipment:** Ms. Nicholas has an adequate supply of age-appropriate equipment for a capacity of 7 children at one time.

**Proposed days and hours of operation:** Care is provided Monday through Friday from 6:00 a.m. to 6:00 p.m.

**Previous or concurrent licenses, including children's foster care:** Ms. Nicholas was previously licensed (DG200087514) from 08/04/1999 through 08/18/2017. Ms. Nicholas is not concurrently licensed for foster care.


**Exiting information (including second floor and basement):** There are three exits from the home. The first exit is the front door, located in the living room, that exits out to the front yard. The second exit is the back door, located in the dining

room, that exits out onto a wooden deck that steps down to the back yard. The third exit is the side door, located in the laundry room, that exits out to the side yard.

**Outdoor play area and description:** The outdoor play area is located in the back yard and is completely fenced in with a wooden fence that has a self-closing lock on the entrance/exiting gate. The home is located on a road that leads to Lake Margrethe, with a distance of approximately 500 feet from the home to the lake. The home and adjacent properties do not have direct access to the lake.

**V. Recommendation**

I recommend the addition of the second bedroom to the approved child use space.
