On 11/16/2021 I received a Request for Modification form (CCL-5054) from Ms. Rush requesting that the maximum age range on her license be changed from 5 years to 6 years of age.

IV. Description of Findings and Conclusions

The terms of the license have been modified on 11/16/2021.

This child care home is a two-story home with a basement located in a residential area in Grand Ledge.

The living room, dining room, kitchen, and two playrooms on the main level of the home are approved for child care use.

The family room on the main level are not approved for child care use. The upper and basement levels of the home are not approved for child care use.

There is a fireplace in the living room of the home. The fireplace is not used during child care hours.

There are two remotely located exits on the main level of the home; a front door and a side door.

The child care home contains a sufficient amount of developmentally appropriate materials and equipment.

The outdoor play area is located in the side yard of the home near the garage. The area is partially fenced in and there are trees and bushes creating a natural barrier to the street. There are no water hazards on the property.

Ms. Rush will provide care for children between the ages of birth to 5 years old.

This child care home operates Monday through Friday from 7:30am to 5:30pm.

V. Recommendation

I recommend approval of increasing the maximum age range to 6 years old.
