IV. Description of Findings and Conclusions

The terms of the original license have been modified on 12/14/2022.

The child care home is a single-story house located on N. Lewis Road between E. Wilson and E. Tobias Roads in Clio.

The living room, dining room, kitchen, one bedroom, and two bathrooms, all on the main level of the home were previously inspected and approved for child care use.

On 12/09/2022 I inspected and approved the following as additional child use space:

- Two bedrooms on the main level of the home for napping and resting.

The main level of the home has two remote exits (front door and side door) and both of them lead directly to the outside.

The home has a basement that is not approved for child care use.

Ms. Moore provides care for children aged birth through 17 years.

Child care hours are Monday through Friday 5:00 am –7:00pm.

Ms. Moore has a variety of age-appropriate toys and equipment sufficient for her licensed capacity.

Outdoor play occurs in the backyard of the home. This area is not fenced and there is elevated (over 30 inches) equipment with sufficient ground cover. Direct supervision is provided at all times.

Ms. Moore is not approved for overnight care and will not provide transportation.

V. Recommendation

I recommend approval of the two bedrooms for napping/resting.
