The bedrooms, kitchen and second living room space are not approved.

Ages of children served:

The home will accept children ages 1 to 12 years of age.

Equipment:

Mrs. Arrington has a wide variety of age-appropriate equipment for all ages. She plans to have the children sleep on the carpeting with bedding, until she obtains cots/mats.

Proposed days and hours of operation:

Mrs. Arrington will operate Monday through Friday from 6:00am - 6:00pm. The child care is closed on the weekend and nighttime care is not approved at this time.

Previous or concurrent licenses, including children's foster care:

Mrs. Arrington has no previous child care licenses. Mrs. Arrington has never been licensed for children's foster care.

Exiting information (including second floor and basement):

The approved exits on the main floor consist of two remote doors from the front and the back of the home.

Outdoor play area description:

Mrs. Arrington plans to take the children to a nearby park, which is within walking distance from the home. She also plans to use the grassy area on the side of the home near the driveway. There is a small ditch with water near the far side of the home, but this area will not be used for outdoor play. Direct supervision will be provided at all times.
