Dear Ms. Mannausau:

This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your home on 04/10/2023. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Family and Group Child Care Homes.

When I arrived on-site, Ms. Lisa Jean Mannausau was present; along with three children in attendance. One child was related to Ms. Mannausau and two were unrelated. The children were engaged in playing with the kitchen toys in the playroom. They appeared happy and comfortable within the care of Ms. Mannausau. Currently, Ms. Mannausau does not have any infants in care; therefore, safe sleep rules were not observed during this on-site visit. She does have a newborn enrolled to attend at the end of the summer and so we reviewed safe sleep rules and diapering procedures.

As a result of the inspection, I did not find any rule or law violations.

Technical assistance and consultation were provided to Ms. Mannausau in the following areas:

- **R400.1907(2) Child's record.** Child in care statements need to be reviewed and updated annually.
- **R400.1912 Infant; child; sleeping; supervision.**
- **R400.1916(5) Bedding and sleeping equipment.** Play yard mattresses must be purchased from the manufacturer of the play yard and be manufactured after February 19, 2014.
- **Diapering and toilet learning.**

- **R400.1934(4) Heating; ventilation; lighting; radon.** Radon test will need to be completed and submitted with the renewal paperwork.


