### III. DESCRIPTION OF FINDINGS & CONCLUSIONS

#### A. Description of Facility

The child care home is a one story, wood-framed structure with a Michigan basement/crawl space. The home is located on a quiet street in the village of Breckenridge.

**Rooms and levels approved for child care use:** On the main level of the home, the front entryway, the living room (including alcove), the (S) bedroom and the (SE) bedroom are approved for child care use. The only bathroom in the home will be used by the child care children.

**Areas not approved:** On the main level of the home the kitchen, the back storage area and the master bedroom are not approved for child care use.

**Ages of children served:** Ms. Freeborn will provide care for children ages birth thru 17 years.

**Equipment:** Ms. Freeborn has an adequate supply of age-appropriate equipment for a capacity of 6 children at one time.

**Proposed days and hours of operation:** Child care will be provided Monday – Thursday from 6:30 a.m. to 5:30 p.m.

**Previous or concurrent licenses, including children's foster care:** Ms. Freeborn has no previous licenses or registrations; including children's foster care.

**Exiting information (including second floor and basement):** There are three exits available on the main level of the home. The front door exits out to a wooden landing that steps down to the (W) yard. The back door exits out to a wooden landing that steps down to the (E) yard. A side door, located in the hallway, exits out to a wooden landing that steps down to the (S) yard.

**Outdoor play area description:** The outdoor play area is a large grassy area that is partially enclosed with a wooden fence. There are no water hazards on or near the property.
