R 400.1907(1)(b)	You did not have any child in care statements on file for the three children enrolled in care.	You indicated that child in care statements will be complete and on file prior to a child's first day.	07/20/2022

R 400.1907(1)(c)	You did not have documentation regarding immunizations, as obtainable on the child in care statement, for the three children enrolled in care.	You indicated that child in care statements will be complete and on file prior to a child's first day.	07/20/2022
R 400.1919(3)	A member of the household turned 14 and did not have a TB test completed.	You indicated that household members will have a TB test completed when they turn 14. Overdue test would be completed.	07/15/2022
R 400.1945(4)	Fire drills were not completed during 2020.	You indicated that fire drills will be completed and documented once per quarter.	07/14/2022
R 400.1945(5)	Tornado drills were not completed in 2020.	You indicated that two tornado drills would be completed and documented during tornado season, March through November.	07/14/2022

It is expected that the corrective action plan will be implemented within the time frames as outlined in your plan.

A follow-up evaluation may be made to verify compliance. Should the corrections not be implemented in the specified time, it may be necessary to reevaluate the status of your license.
