
R 400.1907(1)(b)	One of the children in care did not have a child in care statement on file.	You indicated that children will have a child in care statement. Missing form would be obtained.	01/21/2023
R 400.1907(1)(c)	A statement of immunizations, as obtainable on the child in care statement, was not on file for one child in care.	You indicated that children will have a child in care statement. Missing form would be obtained.	01/21/2023
R 400.1920(5)(a)	You had a swing set in the outdoor play area. The swing set was placed over hard packed dirt and grass.	You indicated that mulch would be installed under the swing set. Swing set will not be used until mulch is installed.	01/18/2023
R 400.1932(2)	A cabinet in the kitchen that contained chemicals was not locked to prevent access from children. The kitchen is used as a pass through for the children in care.	You indicated that chemicals will be inaccessible to children.	01/23/2023
R 400.1945(4)	Fire drills were not being conducted on a quarterly basis.	You indicated that fire drills would be completed and documented each quarter.	01/18/2023
R 400.1945(5)	Tornado drills were not conducted twice between March and November.	You indicated that tornado drills would be completed between March through November.	01/18/2023

It is expected that the corrective action plan will be implemented within the time frames as outlined in your plan.

A follow-up evaluation may be made to verify compliance. Should the corrections not be implemented in the specified time, it may be necessary to reevaluate the status of your license.
