Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center's records, including staff records and children's records. Staff records include background checks and training information. Children's records include child information cards, physical examination dates, and immunizations.

As a result of the inspection there were no violations.

During the onsite inspection I observed free choice, hand washing, and snack. Interactions between Ms. King and the children were positive and developmentally appropriate. There was an adequate amount of age-appropriate play and learning materials. Ms. King uses Teaching Strategies with the children in care.
