II. Purpose of Addendum

Licensee, Angela Miller, submitted a request for modification to increase the capacity of her Family license from 3 to 6, due to the presence of the new licensing rules concerning concurring licensure for children's foster care.

IV. Description of Findings and Conclusions

Ms. Angela Miller possesses a foster care license for up to 2 foster care children through the Ionia County Department of Health and Human Services. Ms. Miller currently has 2 minor-aged household members under the age of 17. Due to the presence of the 2 child foster care license and the 2 minor-aged household members under the age of 17, the capacity of Ms. Miller's child care group license shall be increased to 6.

Previous rooms and levels approved for child care use: Only the main level of the home is approved for child care use. The areas on the main level include: the living room, kitchen, dining room, and two bedrooms.

Ages of children served: The child care facility will serve children ages birth through 17 years.

Equipment: The child care facility has a sufficient supply of developmentally appropriate and varied equipment to accommodate the requested capacity.

Proposed days and hours of operation: Ms. Miller will operate 24 hours a day, seven days per week.


Previous or concurrent licenses, including children's foster care: Ms. Miller currently maintains a 2 child foster care license through the Ionia County Department of Health and Human Services. Ms. Miller has not previously held any additional childcare or adult foster care licensure.

Exiting information (including second floor and basement): There are three doors exits leading directly outside on the main level.

Outdoor play area description: Ms. Miller uses her backyard for outdoor play.

V. Recommendation

I recommend increasing the capacity of Ms. Angela Miller's child care family license capacity from 3 to 6.
