Approved Child Care Use Space:


The main floor living room, kitchen and now, three bedrooms are approved for child care use. In the basement the entry way and the playroom are approved for child care use.

The recreational room in the basement is no longer approved as child care use space.

Exiting Information: On the main level the exits include the front door which exits to grade and the door which leads to the garage and then outside. There is a door in the living room that leads to the deck which contains a pool. Ms. Griswold understands that the pools needs be inaccessible to the children if using this exit. In the basement there is a designated exit window in the playroom and stairs which lead to the main level of the home.

V. Recommendation

I recommend adding in the master bedroom as child care use space and removing the recreational room in the basement from the license.
