This license has been modified on 11/03/2022.

This is a two story, wood-framed home located in a rural area on Paddock LN, near Surrey LN. The child care is located in the main level of the home.

The main level of the home is approved for child care use and consists of the living room, dining room, kitchen and play room. There is a bathroom for the children to use on the main level.

The basement, upper level of the home and side room where the garage was converted, master bedroom and craft room are not approved for child care use. The basement will only be used for weather emergencies.

There is a fully fenced in outdoor play area that will be used for outdoor play. Ms. Haislip will use the back exit of her home to walk the children from the deck, to the fenced in play yard.

On the main level, there is the front door and back door leading to the outdoor play yard that can be used for exiting.


Terms:

Ms. Haislip will serve children ages birth through 17 years of age. Ms. Haislip has plenty of equipment and materials to serve a variety of ages. She has a storage room with extra play materials to change so the children do not become bored with what is available.

Ms. Haislip will now operate her child care Monday through Friday from 6:00AM until 8:00PM.

V. Recommendation

I recommend changing the hours of operation for this child care home to operate between the hours of 6:00AM and 8:00PM.
