II. Purpose of Addendum

I received a modification request from Mrs. Bingle to add a bedroom on the lower level of the home as child approved space.

III. Methodology

03/13/2023 – Modification request received.

03/27/2023 – Inspection Completed Onsite.

IV. Description of Findings and Conclusions

The terms of this license have been modified on 03/27/2023.

This is a two-story home located in a residential neighborhood near the intersection of West Parnall Road and Morrill Road in Jackson.

On the main level of the home, the living room, kitchen, dining room and den are approved for child care use. On the upper level the two bedrooms are approved for child care use. This exceeds the minimum requirement of 35 square feet per child. The lower level of the home is now approved, this includes one bedroom located near the stairwell that leads to the main level of the home. The remainder of the lower level of the home, which includes the laundry room and an office space, are not approved for child care use. The master bedroom on the upper level of the home is not approved for child care use.

On the main level of the home, there is the front door used for exiting. The den has a sliding door that leads to the backyard. On the upper level of the home, there are the stairs that lead to the main level and a remotely located bedroom window used for exiting. In the lower level of the home, there is a door that leads to the backyard and remotely located stairs that leads to the main level of the home.


There is a large, fenced in backyard for the child care children to use.

Terms:

Mrs. Bingle will serve children between the ages of birth to 17 years. The child care home will operate Monday through Friday from 6:30AM until 6:30PM
