## III. DESCRIPTION OF FINDINGS & CONCLUSIONS

### A. Description of Facility

This is a two-story home located in a residential neighborhood near the intersection of West Parnall Road and Morrill Road in Jackson.

#### **Rooms and levels approved for child care use:**

On the main level of the home, the living room, kitchen, dining room and den are approved for child care use. On the upper level the two bedrooms are approved for child care use. This exceeds the minimum requirement of 35 square feet per child.

#### **Areas not approved:**

The basement is not approved for child care use and will only be used for tornado shelter. On the upper level, the master bedroom is not approved.

**Ages of children served:**

Mrs. Bingle will serve children between the ages of birth to 17 years.

**Equipment:**

There is a variety of age-appropriate equipment and play materials.

**Proposed days and hours of operation:**

The child care home will operate Monday through Friday from 6:30AM until 6:30PM.

**Previous or concurrent licenses, including children's foster care:**

Mrs. Bingle has never held a child care license or children's foster care license.

**Exiting information (including second floor and basement):**

On the main level of the home, there is the front door used for exiting. The den has a sliding door that leads to the backyard. On the upper level of the home, there are the stairs that lead to the main level and a remotely located bedroom window used for exiting.

**Outdoor play area description:**

There is a large, fenced in backyard for the child care children to use.


