IV. Description of Findings and Conclusions

During my on-site inspection, Ms. Hardiman stated that she was providing overnight care. I provided technical assistance that she need to notify the bureau when she wants to change her hours of operation. I requested that Ms. Hardiman complete a Request for Modification form (CCL-5054) to request the change of hours.

The terms of the license have been modified on 08/24/2018 and 05/02/2022.

This family child care home is located in a bi-level home in a residential neighborhood in the south-east quadrant of Grand Rapids near the intersection of Hall Street SE and Madison Avenue SE.

The upper level is the only level of the home approved for child care use. On the upper level of the home, the living room, kitchen, dining area, and playroom are approved as child use space. There is a bathroom for the children to access on this level of the home. There are two remotely located exits on the upper level of the home; the stairwell leading to the front door and a back slider leading out to the deck overlooking the backyard. There is no fireplace or wood burning stove in the home.

The upper level bedroom and lower level of the home are not approved as child use space.

The approved outdoor play area is in the front yard and driveway of the home. The front yard is not fenced in. Ms. Hardiman will provide direct supervision when children are using the outdoor play area. There are no known water hazards in the outdoor play area.

The child care home will operate from Monday and Friday 6:00am-8:30pm and Tuesday through Thursday 12:00am to 11:59pm.

Ms. Hardiman will provide care for children between the ages of birth to 10 years of age.

V. Recommendation

I recommend approval of changing the hours to from Monday and Friday 6:00am-8:30pm and Tuesday through Thursday 12:00am to 11:59pm.
