II. Purpose of Addendum

On October 19, 2022, I received a Request for Modification form (CCL-5054) from licensee Yolanda Brown requesting the following changes to her license:

- Change age range of children accepted from birth to 17 years of age to 1 year to 12 years of age.
- Change hours of operation for Monday through Friday from 6:00am to 6:00pm to 6:00am to 5:00pm.

IV. Description of Findings and Conclusions

During the interim inspection I spoke with Ms. Brown concerning the ages of children she will accept and hours of operation. After some discussion she stated the information should be updated. I requested she complete a Request for Modification form (CCL-5054) so I could make the changes to her license.

The terms of the license have been modified on 07/21/2022 and 10/19/2022.

This child care home is located within the southeast quadrant of the city limits of Grand Rapids. The home is a two-story wood-framed structure with a basement. The entire main level of the home has been approved as child care use space. The main level consists of the living room, dining room, playroom, and kitchen. There is a fireplace in the living room of the home. The fireplace is not used while children are in care. There is a bathroom for the children to access on this level of the home. There are three remotely located exits on this level of the home; the front door, and two side doors leading to the side of the home.

The upper level and basement level of the home are not approved as child use space. The basement can be used as a storm shelter.

The outdoor play area is located in the backyard of the home. The area is partially fenced in. There are structures located in the backyard. The structure with the slides is not approved for use by child care children until surfacing has been placed under and around the structure. There are no water hazards in or adjacent to the outdoor play area.

There is a variety of age-appropriate materials and equipment for the children to access.

Ms. Brown will accept children between the ages of 12 months to 12 years of age in care.

The child care home will operate Monday through Friday from 6:00am to 5:00pm.

V. Recommendation

I recommend approval of changing the age range and hours of operation for this child care home.
