and a review of the home's records, including staff records and children's records. Staff records include background checks, medical clearance information, and training information. Children's records include child information cards and child in care statements/receipts.

During my on-site inspection the children were watching age-appropriate programming. There was a variety of age-appropriate materials and equipment for the children to access. The home and child files were organized and readily available. Ms. Crawford has completed more than the required annual trainings.

I provided technical assistance and consultation child records.

The facility is in compliance with all applicable rules and statutes.

I recommend issuance of a regular license to this child care family home (capacity 1-6).
