Findings of the Inspection

The renewal inspection involved a review of all applicable child care center [administrative rules](#) and [statutes](#). Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center's records, including staff records and children's records. Staff records include background checks and training information. Children's records include child information cards, physical examination dates, and immunizations.

During my on-site inspection I observed outdoor play and activity time. Teresa James and Child Care Staff Member 1 were present and providing appropriate care and supervision. They interacted with children in a positive and friendly manner. I heard them use reminders as positive discipline strategies. There was a variety of age-appropriate equipment and materials for the children to access. The home, staff, and child records were organized and made readily available. Teresa James and staff have completed more than the required training hours annually.
