Dear Ms. Pardon:

This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your home on 04/12/2022. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Family and Group Child Care Homes.

During my on-site inspection there were two children in attendance. I observed arrival and free play. The home was clean and there was a variety of age-appropriate materials for the children to access. Ms. Pardon ensured she was providing appropriate care and supervision. She interacted with the children in a positive and nurturing manner. Home, staff, and child files were organized and complete.

I provided technical assistance and consultation on documentation needed for adult household members, and training requirements for child care staff members.

The violations that were found are:

R 400.1905(9) Training.

(9) When the department of licensing and regulatory affairs or the department of education publishes a notice that a new health and safety update document or a new health and safety update training activity has been published on MiRegistry, the licensee shall ensure that all personnel read and acknowledge the document or complete the activity within 6 months of

the notice.

Ms. Pardon did not complete the required Health and Safety Refresher 2021 training on MiRegistry. I have sent Ms. Pardon a private link via email so she can complete the training.

On April 12, 2022, you gave us an acceptable written corrective action plan. There will be no change to your license status.
