III. DESCRIPTION OF FINDINGS & CONCLUSIONS

A. Description of Facility

This child care home is located on a one-way street on the southeast side of Grand Rapids near Eastern Ave SE. The home is a two-story wood framed house.

Rooms and levels approved for child care use:

The living room, dining room, and kitchen on the main floor and two bedrooms on the east side of the second floor are approved for child care use space.

Areas not approved:

Two bedrooms on the west side of the second floor are not approved for child care use. The basement is not approved for child care use but may be used for emergency shelter.

Ages of children served:

Ms. Littlejohn will accept children ages 6 months through 12 years old for care.

Equipment:

Ms. Littlejohn has an adequate supply of developmentally appropriate equipment and supplies.

Proposed days and hours of operation:

Ms. Littlejohn will provide care from Sunday evening at 9:00 PM through Saturday at 7:00 PM. Ms. Littlejohn will provide overnight care for children over 24 months old. She has two twin inflatable mattresses for children who spend the night. She understands that she will need to sleep on the same floor level as the children are on and that each child will need a bed to sleep on.

Previous or concurrent licenses, including children's foster care:

Ms. Littlejohn has not been previously licensed for foster care or child care.

Exiting information (including second floor and basement):

There are two remotely located exit doors on the main floor. The second floor exits include an exit window in the back bedroom on the west side of the home and a stairway leading to the main floor.

Outdoor play area description:

Ms. Littlejohn has a front and back yard that can be used for outdoor play once she completes some cleanup and repairs. Ms. Littlejohn will take the children to Joe Taylor Park which is located down the street until her yard work has been completed.
