III. DESCRIPTION OF FINDINGS & CONCLUSIONS

This renewal inspection involved a review of all applicable child care home administrative rules and statutes. Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the home's records, including staff records and children's records. Staff records include background checks, medical clearance information, and training information. Children's records include child information cards and child in care statements/receipts.

During my on-site inspection, the home was clean and organized. The children were resting when I arrived and then they watched age-appropriate television programming during my inspection. Ms. Tims-Mosley interacted with children in a positive and nurturing manner. She used redirection as a positive discipline strategy. All the home and child files were organized and made readily available.

I provided technical assistance on annual updates to children records and maintaining personal care items and cleaning supplies inaccessible to children.

The facility is in compliance with all applicable rules and statutes.

IV. RECOMMENDATION

I recommend issuance of an original license to this child care family home (capacity 1-6).
