IV. Description of Findings and Conclusions

The terms of the original license were modified on October 25, 2017, and May 2, 2022.

- October 25, 2017 - On October 12, 2017, Mrs. Rebecca Tilson, submitted a modification request form to change the days and hours of operation from Monday through Friday 4:30 A.M. to 10:00 P.M. to Sunday through Saturday, 4:30 A.M. to 11:00 P.M.
- May 2, 2022- On April 19, 2022, Mrs. Rebecca Tilson submitted a modification request form to change the days and hours of operation to Monday through Thursday from 5:00 A.M. to 8:00 P.M.

The child care home is a two-story home with four bedrooms and 2 1/2 baths and is located in a residential neighborhood in Howell, Michigan. The child care home will operate Monday through Thursday, year- round. Hours of operation are 5:00 A.M. – 8:00 P.M.

The playroom and the kitchen, located on the main level of the child care home, are approved for child care.

There are four bedrooms located on the second level of the home. The bedroom located immediately on the right from the stairs is the only room approved for child care use. The children in care will be using the bedroom as a sleeping area. A window has been designated as an exit window. The stairs located by the bedroom leads to the main floor and immediately to the front door.

On the main level, the dining room and living room, the basement and the three bedrooms on the second level of the child care home are not approved for child care use. There are two remote exits from the main floor of the home; one located at the front of the house and the other exit is located at the back of the house by the kitchen.

The outdoor play area is located in the backyard of the house. The yard is not fenced. In the neighborhood, there is a park with a climber located within walking distance from the child care home.

V. Recommendation

I recommend changing the days and hours of operation to Monday through Thursday from 5:00 A.M. to 8:00 P.M.
