III. DESCRIPTION OF FINDINGS & CONCLUSIONS

A. Description of Facility: The child care home is a single-story traditional wood frame constructed house with a basement located in a residential area of Barryton, Michigan.

Rooms and levels approved for child care use: On the main floor, the dining room, living room, playroom, central bedroom and a three seasons room are approved for child care use.

Areas not approved: The basement is not approved for child care use.

Ages of children served: The child care will serve children between birth and 17 years old.

Equipment: There is an adequate amount of play and learning equipment for the age range and capacity requested.

Proposed days and hours of operation: The child care home will operate Monday – Friday from 7:00 AM until 5:00 PM.

Previous or concurrent licenses, including children's foster care: Ms. Taylor has not been previously licensed to provide child care. She is not a licensed foster parent.

Exiting information (including second floor and basement): Exiting available from the main floor via the front (north) door and the rear door located in the three-season room (south).

Outdoor play area description: The outdoor play area is located behind the child care home. Barriers are provided around the entire perimeter of the backyard by 4-foot-high chain link fencing and structures such as the house, garage and a shed. There are no water hazards on the Raymond property or the adjacent properties.

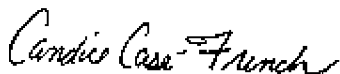
