III. DESCRIPTION OF FINDINGS & CONCLUSIONS

A. Description of Facility

This two story child care home is located in Midland, MI on Westbury Drive between Plainfield St and Foxcroft Drive.

Rooms and levels approved for child care use: The main level of the home is approved for childcare use including the living room, family room, playroom, kitchen, dining room, and laundry room. The bathroom used by children is off of the entryway to the home near the laundry room.

Areas not approved: The basement and the second level of the home will not be used for child care.

Ages of children served: This child care home will serve children ages birth through 17 years.

Equipment: There is adequate equipment for the requested capacity and a variety of ages including infant toys, books, art supplies, imaginative play toys, blocks, puzzles and manipulatives.

Proposed days and hours of operation: This child care home will operate Monday through Friday from 7:30AM-5:00PM

Previous or concurrent licenses, including children's foster care: Kelsey Barrons has no previous child care or foster home licenses.

Exiting information (including second floor and basement): There are four exits in this child care family home. The first exit is the front door which provides egress to the front yard. The second exit is the back door in the kitchen which provides egress to the back yard. The third exit is the door in the playroom which provides egress to the back yard. The fourth exit is in the laundry room which provides egress to the garage and the front yard of the home.

Outdoor play area description: The outdoor play area is in the back yard of the home. There are swings, a climber, push toys, a sandbox, and a small playhouse. There is appropriate ground covering and no water hazards on or adjacent to the property.


