A. Description of Facility:

This is a newly renovated ranch style home located off a minimally traveled dirt road in the North Muskegon area.

Rooms and levels approved for child care use: The dining room, living room, kitchen and south bedroom are approved for child use space.

Areas not approved: The master bedroom, exercise room, and laundry room are not approved for child use space.

Ages of children served: Birth to twelve years of age

Equipment: Ms. Kibble has an adequate amount of developmentally appropriate indoor/outdoor play equipment.

Proposed days and hours of operation: Ms. Kibble will care for children 24 hours a day Sunday through Friday at midnight. She will be closed on Saturdays.

Previous or concurrent licenses, including children's foster care: Ms. Kibble has not held a previous license for child care or children's foster care.

Exiting information (including second floor and basement): You can exit the child care home through the front door, the slider door and the back door of the home.




