Ms. Fatima lives in a single-story home located in a residential neighborhood.

The family room and the Florida room on the main floor are approved for use.

Children will exit out the front door, the rear door, or the side door off the laundry room.

The bedrooms and basement are not approved for child care use.

The children will use the bathroom off the kitchen hallway.

Children will play in the partially fenced backyard.

Ms. Fatima will care for children ages from 3 months to 6 years. The child care home is open from Monday through Friday from 7:30am-5:30pm.

There is an adequate supply of toys and equipment for the children.

A radon test was completed in 12/2020 in the basement with the results of 2.2 pCi/L.

V. Recommendation

The child care family home is now licensed for children ages 3 months to six years.
