Dear Mrs. Lockhart:

This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your home on 02/25/2021. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Family and Group Child Care Homes.

At the time of this onsite inspection, I observed children were watching television. Ms. Lockhart explained that children do not watch more than two hours of television each day. Ms. Lockhart interacted with children in a developmentally appropriate manner. I did not observe any safety concerns.

The violations that were found are:

**R 400.1924**      **Hand washing.**

(2) Personnel shall ensure that children wash their hands at all the following times:

(a) Before and after meals, snacks, or food preparation experiences.

Ms. Lockhart did not ensure that children wash their hands before and after meals, snacks, or food preparation experiences. Children's hands were not washed before being served their snack.

**R 400.1924            Hand washing.**

(2) Personnel shall ensure that children wash their hands at all of the following times:

(b) After toileting or diapering.

Ms. Lockhart did not ensure that children's hands were washed after toileting or diapering. One child's hands were not washed after diapering.

On 3/25/2021, you gave us an acceptable written corrective action plan.
