### A. Description of Facility

This family child care home is located in a 2-story home in a residential neighborhood in Holland, MI.

The main floor master bedroom, the second floor of the home, and the basement are not approved for use.

**Proposed days and hours of operation:**

The hours of operation are Monday through Friday from 5:30am-4:30pm.

The licensee has previously been licensed as a family child care provider (DF700398007). She has not been licensed to provide children's foster care.

The main floor has the front door and back door as exits from the home.
