

The home has no upper level or basement.

III. DESCRIPTION OF FINDINGS & CONCLUSIONS

This renewal inspection involved a review of all applicable child care home administrative rules and statutes. Verification of compliance included direct

observations of the physical environment and the program, discussions with staff, and a review of the home's records, including staff records and children's records. Staff records include background checks, medical clearance information, and training information. Children's records include child information cards and child in care statements/receipts.

Upon arrival Ms. Lewis was providing care to one child upon arrival. I observed Ms. Lewis providing direct supervision of the child during free play time. The child was playing with age-appropriate toys. I observed hand washing and snack time. I observed Ms. Lewis providing emotional support to the child who was getting ready for nap time. The child appeared to be happy and well bonded to the licensee. The home was clean and safe for child care use. Required records were organized and readily available for review.

The facility is in compliance with all applicable rules and statutes.

IV. RECOMMENDATION

I recommend issuance of a regular license to this child care family home (Capacity 1-6).
