IV. Description of Findings and Conclusions

The terms of the original license were modified on June 21, 2023.

A. Description of Facility

The one-story home is located on W. Genesee between Bay Road and Brenner Street.

Rooms and levels approved for child care use: The living room, dining area and kitchen are approved. The master bedroom and two other bedrooms are approved for child use. The master bedroom and one of the other bedrooms are approved for napping only. The second bedroom will be used as an additional play area and also will be used for napping. These bedrooms have an operable smoke detector installed. The bathroom is adjacent to the bedrooms.

Areas not approved: One bedroom will not be used for child care.

Ages of children served: Ms. Pignatelli plans to care for children birth to preschool age.

Equipment: There is an adequate supply and variety of age appropriate toys, materials, and equipment for children's use. It was stored properly and easily accessible.

Proposed days and hours of operation: Care will be provided Monday through Friday, between 7:30am and 5:30pm.

Previous or concurrent licenses, including children's foster care: Ms. Pignatelli has previously been licensed under DF730255802 (2003-2006) and DF730376620 (2015-2018).


Exiting information (including second floor and basement): This home has two exits on the main level. The first exit is the front door which provides egress to the front yard. The second exit is the back door in the kitchen which provides egress to the back of the home.

Outdoor play area description: The backyard for play is entirely fenced with an area set aside for small equipment.
