The purpose of the Interim inspection was to determine compliance with applicable licensing statutes and administrative rules for child care family home.

During the onsite inspection, I observed the licensee providing direct supervision of children napping during rest time upon my arrival. I observed one infant during tummy time. I observed the licensee holding the infant and providing comfort and nurturing. I observed diapering and hand washing. I observed a parent and children during drop off time. The children appeared happy and well bonded to the licensee. The home was clean and safe for children’s use. Required records were organized and readily available for review.

As a result of the interim inspection on 4/15/2024, licensing consultant Mary Smith did not find any rule or law violations.
