

Approved child use space: Mail floor: dining room, kitchen, and foyer/study room. Basement: large child care room. Upper Level: two spare bedrooms and the sitting room. The two spare bedrooms on the upper level will be used for napping and overnight care. Ms. Harris has a bunk bed with a twin on the top and a full-size bed on the bottom, two cribs and queen size bed available for overnight care. Ms. Harris is aware that one caregiving staff person must be on the same floor as sleeping children. There are cots and pack and plays available for napping. There is a full bathroom located on the upper level and a half bathroom located in the basement for children's use.

Exiting information (including second floor and basement): The main level has three remote exits; the front door, side door and back door which are each marked as exits and lead to outside. The second floor has two remote exits; a window that leads to a balcony and stairs leading down to the main level. The basement has two remote exits; an egress window and stairs leading up to the main level.

### III. DESCRIPTION OF FINDINGS & CONCLUSIONS


This renewal inspection involved a review of all applicable child care home administrative rules and statutes. Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the home's records, including staff records and children's records. Staff records include background checks, medical clearance information, and training information. Children's records include child information cards and child in care statements/receipts.

During the on-site inspection, I observed children engaged in free play activities upon my arrival. Children were observed playing with age-appropriate toys. I observed handwashing and lunch time. The children appeared happy and well bonded to the licensee. The home was clean and safe for child care use. Required records were organized and readily available for review.

The facility is in compliance with all applicable rules and statutes.

### IV. RECOMMENDATION

I recommend issuance of a regular license to this child care family home (Capacity 1-6)
