Findings of the Inspection

The renewal inspection involved a review of all applicable child care center [administrative rules](#) and [statutes](#). Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center's records, including staff records and children's records. Staff records include background checks and training information. Children's records include child information cards, physical examination dates, and immunizations.

During the onsite inspection, I observed Ms. Harris providing direct supervision of the children napping during rest time upon my arrival. I observed the children engaged in free play activities. The children were observed playing with age appropriate toys. I observed hand washing and snack time. The children appeared happy and well bonded to the licensee. The home was clean and safe for children's use. Required records were organized and readily available for review.

As a result of the renewal inspection on 7/1/2024, licensing consultant Mary Smith did not find any rule or law violations. A regular license will be issued.
