## **IV. Description of Findings and Conclusions**

The terms of the original license have been modified on December 16, 2022.

The family child care home is a two-story residence with a basement located within the Sturgis city limits. The main floor dining room is approved for child care use. The second-floor master bedroom and a full bathroom have also been previously approved for care. The licensee would like to remove the second bedroom (their master bedroom) from the approved child use space.

The main floor living room, bathroom, and kitchen are not approved for child care use. Two bedrooms on the second level of the home are not approved for care. The basement level of the home is not approved for care except for in severe weather emergencies.

The child care family home is approved to serve children birth through age 17 years. The facility is open Monday through Friday from 5:00 AM to 5:30 PM. The licensee has a sufficient supply of developmentally appropriate and varied equipment to accommodate the requested capacity of 6 children. This is the first child care license Ms. Perez has had and she has never been licensed for children's foster care.

The main level of the home has a front door and a back sliding door. The second level of the home has a designated window exit in the master bathroom that is used for care and stairs leading to the main level of the home.

The outdoor play area is located behind the home and is not fenced. Portable playground equipment will be used with the children in care.

The child care home has one large Husky dog. There are no hot tubs, spa pools, swimming pools, or other water hazards on the premises. There are no fireplaces or wood stoves in the home. No variances have been requested or approved.

**V. Recommendation**

I recommend approval of the modification to remove one upstairs bedroom from the approved child use space.
