II. Purpose of Addendum

On 03/03/2022 Ms. Krzewinski requested the approval of the game room in her home as additional child use space.

III. Methodology

IV. Description of Findings and Conclusions

The terms of the original license have been modified on 03/11/2022.

The child care home is a single story house located on Handy Road near Ball Road in Caro.

The following space was previously inspected and approved as child use space:

- The refinished garage attached to the home, including one bathroom.
 - The garage has two remote exits (front door and back door) and both lead directly to the outside.

On 03/03/2022 I inspected and approved the following as additional child use space:

- The game room that is on the other side of the doors leading into the refinished garage.
 - The main level of the home has four remote exits (front door, back door, side door, and the doors leading into the garage) and three of them lead directly to the outside.

Both of the approved rooms are located on the main level of the home. Ms. Krzewinski will keep the French doors open when she has children in both rooms, allowing her to monitor the children in both rooms.

There is a fire place in the living room that is not used during child care hours.

Ms. Krzewinski provides care for children aged 18 months through 8 years of age.

Child care hours are Monday through Friday 7:00 am –5:00 pm.

Ms. Krzewinski has a variety of age appropriate toys and equipment sufficient for her licensed capacity.

Outdoor play occurs in the yard located on the north side of the home. This area is fenced and there is elevated (over 30 inches) equipment with sufficient ground cover.

- There is a pool located on the south side of the home that is protected by a 4-foot locked barrier and is not used with child care children.

Ms. Krzewinski is not approved for overnight care and does not provide transportation.

V. Recommendation

I recommend approval of the play room as child use space.
