## **IV. Description of Findings and Conclusions**

The terms of the original license have been modified on 03/11/2022 and 06/16/2023.

The child care home is a single-story house located on Handy Road near Ball Road in Caro.

The following space was previously inspected and approved as child use space:

- The refinished garage attached to the home, including one bathroom.
  - The garage has two remote exits (front door and back door) and both lead directly to the outside.

There is a fire place in the living room that is not used during child care hours.

Ms. Krzewinski provides care for children aged 18 months through 8 years of age. Child care hours are Monday through Friday 7:00 am –5:00 pm.

Ms. Krzewinski has a variety of age-appropriate toys and equipment sufficient for her licensed capacity.

Outdoor play occurs in the yard located on the north side of the home. This area is fenced and there is elevated (over 30 inches) equipment with sufficient ground cover.

- There is a pool located on the south side of the home that is protected by a 4-foot locked barrier and is not used with child care children.

Ms. Krzewinski is not approved for overnight care and does not provide transportation

**V. Recommendation**

I recommend removal of the game room as child use space.
