A. Description of Facility

The two-story home is located in the rural area of Lawton, Michigan. The second story is a loft that is used primarily for storage. There is a detached garage near the home.

Rooms and levels approved for child care use: The living room, dining room, kitchen, second living room, bathroom located in the second living room, Bedroom 1 and main bathroom are approved for child care.

Areas not approved: The master bedroom and the loft are not approved for child care.

Ages of children served: The licensed family home will serve children birth through 17 years of age.

Equipment: There is adequate developmentally appropriate equipment for six children ages birth to 17 years. Equipment includes a pack 'n' play, pop-up toys, cars/trucks, books, infant toys, foam blocks, Barbie dolls, push toys, sensory tubes/toys, and art supplies.

Proposed days and hours of operation: The licensed family home will operate Monday through Friday from 7:00 am to 5:30 pm.

Previous or concurrent licenses, including children's foster care: Licensee Amanda Card does not have any previous or concurrent licenses.

Exiting information (including second floor and basement): The front door, back door and side slider are used for exiting the home.

Outdoor play area description: The outdoor play area is located in the side yard adjacent to the home. There is no fence but there are trees and bushes that create a natural barrier.


