Ms. Robinson will ensure that her child in care statements reflect that someone in the home smokes and will inform parents at enrollment.	03/31/2024
R 400.1907(1)(b)	Two out of six child in care statements had the disclosure marked no. One out of six child in care statements did not have the disclosure marked at all. One out six child in care statements was missing.	Ms. Robinson has updated all child in care statements for all children enrolled in care. Ms. Robinson will ensure that prior to a child attending care that all child in care statements is filled out accurately and complete. Additionally, Ms. Robinson will not provide care until all required forms are complete.	1/30/2024

It is expected that the corrective action plan will be implemented within the time frames as outlined in your plan.

A follow-up evaluation may be made to verify compliance. Should the corrections not be implemented in the specified time, it may be necessary to reevaluate the status of your license.
