

## III. DESCRIPTION OF FINDINGS & CONCLUSIONS

This renewal inspection involved a review of all applicable child care home administrative rules and statutes. Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the home's records, including staff records and children's records.

Staff records include background checks, medical clearance information, and training information. Children's records include child information cards and child in care statements/receipts.

During the inspection, the child care home was found to be in compliance with all applicable rules and statutes except for the following violations:

**R 400.1925                    Comprehensive background check; fingerprinting.**

**(2) An applicant or licensee shall do all of the following:**

**(b) Maintain a copy of the completed and signed form(s) for each individual entered into the child care background check system under the license.**


On 09/07/2022 Ms. Laporte did not have a completed and signed copy of the consent and disclosure form for herself or her adult household member

Technical assistance was provided regarding updating the child in care statement cards to the new editions as well as making sure all child information cards have been reviewed annually. Technical assistance was also provided regarding continuing to clear some of the clutter out of the bedrooms. Ms. Laporte has cleaned some of the clutter away from where the children sleep but more should be moved out. Technical assistance was also provide regarding making sure that all food items, including lunch boxes and water bottles, are labeled with the child's first and last name.

A corrective action plan was requested and approved on 09/07/2022. It is expected that the corrective action plan be implemented within the specified time frames as outlined in the approved plan. A follow-up evaluation may be made to verify compliance. Should the corrections not be implemented in the specified time, it may be necessary to reevaluate the status of your license.

**IV. RECOMMENDATION**

I recommend issuance of a regular license to this child care family home (capacity 1-6).
