The terms of the original license have been modified on 10/12/2022.

### **Rooms and levels approved for child care use:**

The main level of the home is approved for child use space. The rooms approved for child use space in this child care home are:

Room #1 is playroom (living room). It is located on the westside of the home.

Room # 2 is the dining room of the home.

Room #3 is a bedroom which is located on the NW side of the home.

The new approved room for child use space is Room #4, a bedroom. This bedroom is located on the NW side of the home. This room is sits off from the dining room.

The bathroom is located on the east side of the home on the main level. There is 1 toilet and 1 sink for children's use.

### **Areas not approved:**

The upper level, and the kitchen are not approved for children's use.

### **Ages of children served:**

Ms. Link serve children birth-17 years of age. 3

**Equipment:**

The family home has an adequate amount of developmentally appropriate indoor and outdoor equipment and the discipline policy reflects positive guidance and discipline techniques that will be used to direct children’s behavior.

**Proposed days and hours of operation:**

The family home will operate from 5:00a.m. to 5:00p.m Monday through Friday.

**Previous or concurrent licenses, including children's foster care: Ms.**

Link is not currently licensed to provide children’s foster care and she has not been previously licensed to provide childcare or children’s foster care.

**Exiting information (including second floor and basement):**


The remote exits in the home include the front door leading to the west side of the home and the back door leading to the east side of the home.

**Outdoor play area description:** Ms. Link has a large yard that is divided into two areas. The area on the southwest side of the home will not be used for childcare children. The area on the northwest side of the home will be used for childcare children. The entire yard is completely fenced and there are not any water hazards in the play area.

Ms. Link has a small dog who is kept away from the child use space during child care hours.
