

training information. Children's records include child information cards and child in care statements/receipts.



The facility is in compliance with all applicable rules and statutes.

The licensee lives in a neighborhood where families do not have the resources to pay private childcare. Most families are eligible for Head Start and GSRP. There are no children enrolled in this childcare home. The licensee has reached out to GSQ for referrals. I encouraged her to try community organizations in her neighborhood for referrals and to leave flyers. I also encouraged her to seek out Matrix for referrals

#### IV. RECOMMENDATION

I recommend issuance of an original license to this child care family home (capacity 1-6).
