Ms. Valentine requested to add the basement as approved child use space. The basement includes the following rooms: lower family room, game room, play room, and nap room.

IV. Description of Findings and Conclusions

The terms of the original license have been modified on 09/06/2022.

Rooms and levels approved for child care use: On the main level of the home the living room, kitchen, dining area, and one bedroom (SE) are approved for child care use. The basement, which includes the lower family room, game room, play room, and nap room are approved for child care use. There is a bathroom available for the children to use on the main level and also in the basement.

Areas not approved: On the main level, the master bedroom (SW) and one additional bedroom (NW) are not approved for child care use. In the basement, the storage room and behind the snack bar located in the game room are areas not approved for child care use.

Ages of children served: Ms. Valentine will provide care for children from birth to 17 years old.

Equipment: Ms. Valentine has an adequate amount of developmentally appropriate equipment accessible for children to use. Ms. Valentine has floor manipulatives, art supplies, books, puzzles, games, books, and various types of blocks for building.

Proposed days and hours of operation: Ms. Valentine will care for children from 12:00 AM – 11:59 PM Sunday through Saturday, year-round.

Previous or concurrent licenses, including children's foster care: Ms. Valentine has not held any previous or concurrent licenses, including children's foster care.

Exiting information (including second floor and basement): On the main level of the home there is a front door, sliding door off the dining room, and a garage door that can be used for emergency escape. Exiting from the basement includes a

stairway leading to the main level and a labeled exit window located in the nap room. The window is in compliance with R 400.1943(12)(a-e).

Outdoor play area description: Ms. Valentine's play area is located behind her home. The backyard is grassy, has many trees that will provide shade for play, and is surrounded by fencing. There is a climber with appropriate ground cover. In addition, Ms. Valentine has a small coupe car, a mail box, water table, Little Tykes cabin, sand box, a rocking horse, and wading pool available for children to use. Rules regarding water activities and wading pools were reviewed with Ms. Valentine at the time of her original inspection.

V. Recommendation

I approve the modification to add the basement as approved child use space. The basement includes the following rooms: lower family room, game room, play room, and nap room.
