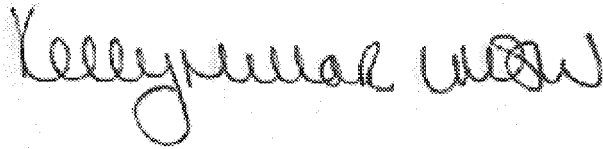

R400.1931(13) Food Preparation and service	There was a child walking around with his cup in the play area. REPEAT VIOLATION ESTABLISHED LSR 09/28/2019 CAP 10/02/2019	Licensee will ensure children are not walking around or lying-in bed with cups or bottles.	10/28/2022
R400.1932(1) Home Maintenance and safety	There is a hole in the living room, behind the door.	Licensee will ensure the hole in the wall is repaired.	11/15/2022
