This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your home on 05/20/2022. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Family and Group Child Care Homes.

The violations that were found are:

R 400.1905

Training

(9) When the department of licensing and regulatory affairs or the department of education publishes a notice that a new health and safety update document or a new health and safety update training activity has been published on MiRegistry, the licensee shall ensure that all personnel read and acknowledge the document or complete the activity within 6 months of the notice.

Ms. O'Toole did not take the 2020 refresher course in MiRegistry. I sent her the link for completion of the training.

R 400.1915

Indoor space; play equipment and materials.

(5) As required by section 15 of the children's product safety act, 2000 PA 219, MCL 722.1065, a licensee shall conspicuously post in the child care home an updated copy of the

list of recalled or unsafe children's products that is provided by the department through its Michigan Child Care Matters (MCCM) online newsletter and available at the department's website www.michigan.gov/mccmatters.

At the time of the onsite inspection, Ms. O'Toole did not have conspicuously posted an updated copy of the list of recalled or unsafe children's products. Ms. O'Toole's printer was not working and could not print the list.

On 05/20/2022, you gave us an acceptable written corrective action plan.
