R400.1907(2)	I reviewed 14 children's files. Of the 14 children's files 7 child information cards and 7 child in care statements were not updated annually. Ms. North was unaware that the child information cards or the child in care statements had not been updated.	Ms. North will have parents complete child information cards and child in care statements forms dated 2022. Ms. North and child care staff members will audit children's files quarterly.	2/10/23
