Dear Ms. Beeson:

This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your home on 03/31/2021. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Family and Group Child Care Homes.

When I arrived on-site Ms. Carrie Beeson and adult household member/child care staff member Mr. Marcus Beeson were present; along with five children in care. Ms. Beeson was in the process of preparing lunch; which consisted of popcorn chicken, mandarin oranges, green beans, bread/butter and milk. The children were engaged in free play and watching Paw Patrol while lunch was being prepared. The children were observed washing their hands prior to eating. Ms. Beeson and Mr. Marcus Beeson attended to the children's wants and needs in a timely fashion.

I observed Ms. Beeson speaking calmly to the children, redirecting their behavior, providing easy to follow 1-2 step directions and using conflict resolution when there was a dispute between two of the children in care. The children appeared to be happy and comfortable within the care of Ms. Beeson and Mr. Marcus Beeson, they were familiar with the daily routine and expectations. Ms. Beeson's space was clean well organized. She provided a more than adequate amount of toys and equipment for the children to interact with and use.

As a result of the inspection, I did not find any rule or law violations.

- **Referenced the Guidelines for Safe Child Care Operations During COVID-19 to assure that Ms. Beeson is following all applicable items.**


