

R400.1923(2)(e) Diapering and toilet learning.	Ms. Skinner was observed changing the swim diapers of three children and only cleaning and sanitizing the changing pad after the last child had been changed.	The changing pad will be sanitized and cleaned after each use. Refill bottles to keep outside every morning.	07/21/2022
R400.1924(1)(b)(i) Hand washing.	Ms. Skinner did not wash her hands in between changing the swim diapers of three child care children.	No more swimming diapers for kids. Ms. Skinner will come inside to wash hands after every diaper change.	07/21/2022
R400.1924(2)(b) Hand washing.	Three child care children did not wash their hands after Ms. Skinner had changed their swim diapers.	Kids will come inside to wash their hands after diapers.	07/21/2022
R400.1925(2)(f) Comprehensive background check; fingerprinting.	Ms. Skinner did not immediately "disconnect" child care staff member Ms. Kayla Hartman from her Child Care Background Check account when she found out that Ms. Hartman would not be returning as a child care staff member.	Ms. Skinner will remove Ms. Kayla Hartman from the website [account] and will immediately remove employees when they are done working with her.	07/21/2022
