Dear Ms. McClintic:

This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your home on 03/27/2023. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Family and Group Child Care Homes.

When I arrived on-site, Ms. Kelly McClintic was present; along with child care staff member Ms. Christina Sandborn. Ms. Sandborn's older daughter was also present, but was not caring for child care children. There were seven unrelated children and three related children in attendance. The children were observed engaged in free choice time and watching a Disney movie.

The violations that were found are:

R 400.1916 Bedding and sleeping equipment.

(5) Play yard mattresses must be purchased from the manufacturer of the play yard and be manufactured after February 19, 2014. Play yards must meet the Consumer Product Safety Commission safety standards for play yards, 16 CFR part 1221 (2019). Licensees shall comply with this subrule by December 31, 2019. These standards are available at <http://www.cpsc.gov>. They are also available for inspection and distribution at the Michigan

One of the play yards that Ms. McClintic was using had a manufacturer's date of
November 2000.

On 03/27/2023, you gave us an acceptable written corrective action plan.

Technical assistance and consultation were provided to Ms. Kelly McClintic in the
following areas:

- **R400.1925(2)(e) Comprehensive background check; fingerprinting.** Within
the Child Care Background Check account: add child care staff member to
Daniel McClintic's role; "disconnect" child care staff member Brenda Graham.


