On 11/18/2020, Ms. Graham requested the addition of the bedroom, located in the basement, to be added to the approved child use space.

IV. Description of Findings and Conclusions

The terms of the original license have been modified on 09/20/2019 and 11/24/2020.

A. Description of Facility

The child care home is a one-story wood framed home with a partially finished basement, on a busy road, in the city of St. Louis.

Rooms and levels approved for child care use: On the main level, the kitchen is approved for child care use. In the basement, the preschool room (SE), the daycare room (NE) and the bedroom are approved for child care use.

Areas not approved: On the main level, the dining room, living room and two bedrooms are not approved for child care use. In the basement, the storage room is not approved for child care use.

Ages of children served: Ms. Graham will provide care for children ages birth thru 17 years.

Equipment: There is an abundant amount of indoor and outdoor equipment available to children of all developmental levels.

Proposed days and hours of operation: Ms. Graham will provide care Monday – Friday from 6:00 a.m. to 5:30 p.m.

Previous or concurrent licenses: Ms. Graham has previously been licensed to provide child care (DF370097441) and has not been licensed as a foster care home.


Exiting information (including second floor and basement): There are two exits available on the main floor; the front door exits out to a cement landing with two steps down to the driveway and the back door exits out to two steps down to the driveway. There are two exits available in the basement; the main stairway

leading up to the back door located on the main level of the home and an egress window located in the bedroom.

Outdoor play area description: Ms. Graham has a backyard with a large grassy area for the children to run and play and a large fenced in area. There is a climbing structure with adequate ground cover and a wide variety of toys and activities for the children to engage in while playing outside. There are no water hazards on or near the property.

V. Recommendation

I recommend the addition of the bedroom, located in the basement, to be added to the approved child use space.
